
### WHAT'S NEW

Did you hear? It's finally happening. After a four-year hiatus, small caps are winning again. During October, Russell 2000 Index rose over 2.0%, beating the S&P 500 by 475 basis points. Small caps also outperformed in September. I'm not sure when you can call something a trend, but this sure feels like one, and it is likely just getting started. Interestingly, despite the recent small cap strength, valuations versus large caps still look extremely inexpensive relative to history (13th percentile). Importantly, fundamentals are getting much better. The proof is in sales and earnings revisions among published analyst forecasts. Small caps are seeing the steepest positive trajectory of sales and earnings revisions in over a decade!

Investors are starting to notice small caps again, but so are other companies. Mergers and acquisitions continued their torrid pace in October with another 10 public companies announcing the purchase of other public companies, a sharp uptick from recent trends. 

The **S&P 500 Growth Index** measures growth stocks using three factors: sales growth, the ratio of earnings change to price, and momentum. S&P Style Indices divide the complete market capitalization of each parent index into growth and value segments. Constituents are drawn from the S&P 500. **Standard deviation** is a measure of volatility. **Sharpe ratio** is a calculation that reflects the reward per each unit of risk in a portfolio. The higher the ratio, the better the portfolio's risk-adjusted return is.
