
OVERVIEW


May was another remarkable month for the convertible market. Activity remained strong in the U.S. with more than \$20 billion in new issuance—making it one of the busiest single months on record. This brings the year-to-date total to more than double what was seen at this point last year. At the same time, there was broad demand for convertibles as every sector posted positive returns for the month. The overall convert market is positive year-to-date despite the broader S&P 500 equity market remaining in negative territory.

Volatility in financial markets has been elevated this year and may continue as markets grapple with the details of economic restarts and the uncertainty of upcoming elections in the fall. We continue to see a healthy mix of new and existing convertibles that provide an attractive opportunity set to help manage through this volatility and position portfolios with the goal of capturing further potential upside in equities, while also helping manage downside risk.




JUNE 30, 1995 TO MAY 31, 2020





CONVERTIBLE MARKET COMPOSITION AS OF 5/31/20
